No.P.11011/1/2025-AMC(BW) : All Technical License Holders registered under the AMC Building Regulations are informed that Annexure B-I has been amended vide the Aizawl Municipal Corporation Building (Amendment) Regulations, 2025 dated 21st November, 2025, to allow **Self-Certification by Empanelled Technical Personnel in Building Plan Approvals and Joint Inspections for Ordinary Building of plot size less than 93 square metres and located within low and moderate geo-hazard zones.** However, if any irregularity or complaint is received, Aizawl Municipal Corporation is empowered to take appropriate actions.
