

**The Aizawl Municipal Corporation
PET (Dog and Cat) REGULATIONS.**

The Mizoram Municipalities Act, 2007 hnuia Section 371-in thuneihna a pêk angin, Aizawl Municipal Corporation chuan a huam chhunga ran (ui leh zawhtê)enkawl dâñ, chhinchhiah leh khuahkhirh kawngahhetiang hian inkaihhruaina dâñ a siam:-

1. Inkaihhruaina dâñ hming leh hman ṭan hun:-

- (a) He inkaihhruaina dâñ hi ‘Aizawl Municipal Corporation Pet (Dog and Cat) Regulations’ tih a ni ang.
- (b) He dâñ hi Aizawl Municipal Corporation huam chhunga hman tur a ni.
- (c) Official Gazette kal tlanga Aizawl Municipal Corporation-in hriattirna a pêk chhuah ni aṭangin he dâñ hi hman tur a ni ang.

2. Hrilh fiahna:-Awmze hrang kawhtir tuma hman a nih loh chuan, he dâna:

- (a) “Act” tihhian Mizoram Municipalities Act, 2007 a kâwk ang;
- (b) “neitu/vulhtu”tih chuan ui leh zawhte neitu bâkah a neitu hriatpui emaw, hriatpui loh emaw pawha kawltu leh enkawltu a huam tel ang;
- (c) “registration authority” tih chu Aizawl Municipal Corporation sawina a ni;
- (d) “khawlai ui/zawhtê” tih chu mihring chênpui loh**leh neitu neilo**, kawtthlêr, park leh kawng dunga khawsau/zawhtê sawina a ni;
- (e) “Veterinarian”tih chuan sawrkar hriatpui veterinary college aṭanga degree neia Mizoram State Veterinary Council-a inziak lût (register)-techauh a huam ang;
- (f) “QR code pet tag” tih chukhâwl hmanga ran vulh chhinchhiahna (digital pet ID tag) sawina a ni.Ran vulhte chhinchhiah nana phone number chhut chawp hman ngai lovin, heng tag-ah hian QR codea awm a, a neitu biak theihna nena inthlun zawm a ni. Miin QR code chu a scan chuanchumi ran vulhtu biakpawh theihna tur a hre thei ang;
- (g) He inkaihhruaina dâñ puala hengṭawngkam hrilh fiahtebâkah hian thu leh thil sawi fiahna ṭawngkam dang hman, hrilh fiah si loh,Mizoram Municipalities Act, 2007-in a lo sawi fiah tawh si a awm a nih chuan, chung ṭawngkamte chuan chuAct-a a awmze hrilh fiahna chu an puchhunzawm zel ang.

3. Registration ti lo leh vaccine la lova ui/zawhte vulh khapna dâñ:-

- (a) Registration form duan sa (Form 1) hmanga registration authority hnenah register lohin,tu mahin thla thum tling tawhui/zawhtê kawl phal a ni lo.
- (b) Ran vulhtute’nhri (rabies) danna damdawi hmangin an ui/zawhtê an chiutir tura ni a, registration an tih dawnin anvaccine lâk finfiahna an keng tel bawk tur a ni.

4. Registration certificate lehQR code pet tag pêk chhuah chungchang:-Ui/zawhte vulhtu zawng zawngin thla thum tling chin ui/zawhtêan lâk aṭanga thla hnih chhungin, registration authority hnen aṭangin registration certificate leh QR code pet tag an la tur a ni. Ui/zawhtêchua inhliam avang te, hri a kai avang te leh a dam loh avang tea nghâwngawrh (collar) a awrh thei lo a nih ngawt loh chuan, register tawh ui/zawhte vulhtute chuan QR code chuanna nghâwngawrh chu eng lai pawhin an awrhtir tur a ni.

5. Ui/zawhte registration tih man leh hri danna lâk man:-

- (a) Ui/Zawhte register nan hian a man Municipal Commissioner in a bithliah ang zel pek tur a ni a, a man pekna receipt, registration certificate leh QR code pet tag te pek chhuah a ni ang.
- (b) Ran hri (rabies) danna vaccinehi kum tin lak tur a ni a, vaccinehi Aizawl Municipal Corporation-ah a lâk theih a,a man hi Corporation-in a tuk zât zel a ni ang.Tin, State Veterinary Polyclinic Hospital aṭang te, dispensaries, private veterinary clinic aṭang te leh veterinarian hnen aṭang tein a lâk theih bawk ang a, anni hian hriatpuina lehkha an pe chhuak tel ang.

6. Registration dam chhung leh tihnu(renewal)dân:-Registration hi kum thum chhung a dam ang a, a thih hma ngeia tihnu leh tur a ni.A tira register man lehatihnu man hi a inangang a, kum thum chhung a dam ang.

7. Ran neitu/vulhtu inthlâk chungchang:- Ui/zawhte neituchu an inthlâk emaw, awmna hmun (address) an thlâk/sawn emaw, ui/zawhtê a bo emaw, a thi emawa nih chuan chutiang a thlen aṭanga thla khat chhung ngeiin registration authority hnenah inhriattir tur a ni.

8. Ran khung khâwmna hmun (shelter/pound):-Ui leh zawhte manteenkawl an nih theih nan Local Council chuan a khung khâwmna hmun (shelter/pound) an buatsaih tur a ni. Ran mantechu a neitu hnena an kîr leh hma zawng emaw,in thara lâk (adopt) an nih hma zawng emaw chuan he hmunah hianenkawl leh ngaihven an ni ang.

9. Ui/zawhte man chungchang:-

- (a) **Register loh ran man theih dân:** Inkaihhruaina dân 4-nain a tar lan anga ui/zawhte nghâwngawrh awrh lo leh QR code pet tag nei lo apiang chu neitu neilo ui/zawhte chuang anga ngaih a ni ang. Chutianga register loh ran chu khawilaiah a chhuak a ni emaw a neitu in leh lo pâwna a awm emaw a nih chuan man theih a ni.

- (b) **Register tawhran man theih dān:** Ui/Zawhte register tawh a neitu tel lova khawlai chhuak hmuh an nih chuan man theih an ni.
- (c) **Ran neitu tel lova chhuak thlalak :** *Ui/Zawhte neitu tel lova khawlai chhuak hmuh an nih chuan, a hmutu in thla la in, Local Council ah an thehlut thei ang a, ran neitu chu Aizawl Municipal Corporation in a tuk ang zat zel pawisa chawitir a ni ang.*
- (d) **Ran mantu tur ruat:** *Aizawl Municipal Corporation in ran neitu tel lova chhuak te man theitu tur hi a ruat thei ang. Ran mante uluk taka enkawl leh a dah khawmna hmuna hruai thlen chua man tute mawhphurhna a ni ang.*
- (e) **Ran mante khul theih hun chhung/khultu neilo:** *Ran mante neitu chuan an ran teman an nih atanga ni 2 hun chhungan an khul tur a ni. Huntiam chhunga khul loh leh khultu neilo ran te chu in thar/neitu thar zawnsak an ni ang.*
- (f) **Ran mante buaipui dān:** Ran chu man a nih hnuah a khung khâwmna hmun (shelter/pound) buatsaihah khung tur a ni. Chumi hmun enkawl tura ruat chuan ran chu a awmna tur dik takah, him takin a awmtir ngei tur a ni.
- (g) **Ran mante enkawl dān:** *Ran khung khâwmna hmun enkawltu chu ran mante kham khawp ei leh in buatsaih kawnga mawhphurtu a ni. Ran hrâi man leh châwi tur dang awmtechu a khât tâwkin Aizawl Municipal Corporation-in a ruahman zel ang.*
- (h) **Sum leh pâi lama mawhphurhna:** *Ran mante hrâi man leh enkawl man bâkah khul chhuahna man chu ran neituin a tumin a châwi zel tur a ni ang. Châwi zât tur chu a țul ang zelin Aizawl Municipal Corporation-in a siam rem ang.*
- (i) **Mawhphurna ti duhlo:** *Ran man khungkhawmna hmun a lo enkawltu senso, hun tiam chhunga pe duhlo ran neitute chu AMC ah thlakhat chhung ngei a report tur a ni. Hetiang a enkawl man pe duh lo te chu AMC in a tul angin an chungah hma a la ang.*

10. Khawlai ui/zawhte khuahkirh dān:- Khawlaia ui/zawhte vâk vêl an pun zel loh nan Municipal Commissioner-in emaw, Municipal Officer tu pawhin emaw, hemi chungchanga Municipal Commissioner-in Municipal hnathawkta a ruat emaw chuan a theih ang angin heng khawlai ui/zawhtê-te hi, mi mal leh welfare pâwl-te tanpuina nen, an tichingin, awlsam taka hri/natna an kai theih loh nan hma an la tur a ni.

11. Ui seh vân dâñ:-

- (a) **Hruia kaih leh thunun:** Vantlang hmun apiangah ui chu kaih zel tur a ni. A kaihna hrui chu feetruk (6) aiin a sei tur a ni lo.
- (b) **Hmui phuarsak:** Vantlang hmuna awmin ui breed thinchhia leh hlauhawm nia hriatte chu mihring leh ran dang an seh theih loh nan hmuiphuarsak (muzzle) hmanga an hmuiphuarsak thin tur a ni.
- (c) **Thlithlai leh khuahkhirh:** Uuinmi a seh loh nan leh mi a sual loh nan ui neitu chuaneng lai pawhin a ui chu a thlithlaiin akhuahkhirh reng tur a ni a; nausêñ, naupang leh hmelhriat loh an awmin a fimkhur lehzual tur a ni.

12. Ui seh/sual vanga hrem theihna dâñ:-

Ui vulh laiin mi a seh emaw mi a sual emaw a nih chuan heng a hnuasia tar lante hi ui neitu chungah a tla ang:

- (a) **Lei châwi:** Aizawl Municipal Corporation-in a tuk ang zelin ui neitu chulei châwitir a ni ang.
- (b) **Inentirna senso:** Uuin a seh/sualte inentirna senso zawng zawng chu ui neitintumsakin, a mawphphurhna a ni ang. Hei hian a huamte chu (a dang pawh a tel thei ang):
 - i. Rang taka damdawi hmanga enkawl (emergency medical treatment).
 - ii. Damdawi in senso.
 - iii. A hnuia ngaihven chhunzawm zel leh dam chian theih nana enkawl.
 - iv. **Lirthei hman man.**
- (c) **Ti thei lo tan:** Lei châwitir zât emaw damdawi hmanga inenkawlna man emaw pe thei lo an awm chuan, Bharatiya Nyaya Sanhita hnuasia Section 291(**Thlaruk chhung lungin tantir anih loh pawhin Rs 5000 chawitir/ a pahnihin**) -a dâñ zam a nih angin, an chungah hma lâk a ni ang a, châwi belhtir an nih loh vêk pawhin an ui vulh lai chu chhuhsak an ni ang.

13. Ransa ngaihven lehngaisak chungchang (Animal Welfare & Anti-Cruelty):-

- (a) **Ransa chunga nunrâwn khapna:** Ran sawisak, nghaisak, thlahthlam, ngaihthah leh hliam hi khap tlat a ni. Ran vulhtute chuan an ran vulhte tana ei leh in tur bâkah, an chênnâ tur buatsaihin damdawi tha hmanganan enkawl thei tur a ni.
- (b) **Enkawlna tehkhâwng:** Ran awmna hmun leh chhehvel chua faiin a him tur a ni a, a hrisel bawk tur a ni. Ran rêng rêng chuan kham khawp tui leh chaw pêk tur a ni. An hrisela an nunphung a that theih nanan mamawh ang zelin damdawia enkawl bawk tur a ni.

(c) **Sawiselna leh hêkna:** Tawngkain emaw ziakin emaw ui leh zawhte enkawl thanan nih loh thu leh an chunga hleilenna lantir thu dawn a nih chuan Aizawl Municipal Corporation-in a tul angin hma a la ang.

(d) **Khauh taka ui insualtir khapna dâñ:**

- i. **Ui insualtir hi dâñ phal loh a ni**-Prevention of Cruelty to Animal Act, 1960 zul zuiin, eng pâwl tan pawh ui insualtirnaa tel emaw ui insualtir châwi lâr emaw chu khap bur a ni a, chutiang ti chu dâñ phal loh thil tia ngaih an ni ang.
- ii. **Inhremna dâñ**-Mi mal tu pawh ui insualtirnaa inhnamhnawih nia hriat chu na taka hrem an ni ang a, Prevention of Cruelty to Animal Act, 1960-a Section 11 (*Dan vawikhat bawhchhia chu Rs 50 thleng chawtir, kumthum chhunga bawhchheh nawn tu chu Rs 25 atanga Rs 100 chawitir a nih loh pawhin kum thum thleng lungin tan/a pahnih in*) leh *Bharatiya Nyaya Sanhita, 2023 hnuai Section 325 (Kum nga thleng lungin tantir anih loh pawhin pawisa chawitir/ a pahnihin)*-in a sawi angin, sum châwitir an nih theih bâkah tân-ina khung theih an ni bawk ang.
- iii. **Ui chhuhsak leh enkawl chungchang**-Insualtirnaa ui tel chu a neitu kut ata chhuhsak an ni ang. Heng uite hi enkawl dam  ain, nunphung pangngai leh hrisel tak nei tur leh hman sual an nih tawh loh nan in thar zawnsak an ni bawk ang. Insualna avanga hliam enkawlna senso zawng zawng ui neitu in a tum tur a ni ang.

14. Hnawksak leh sawiselna:-

- (a) Ui leh zawhtê-te chu  enawm khawvengte tana hnawksak an **ni** tur a ni lo va, ninawm leh bengchheng khawpa ui an bauh loh nan te, vantlang hmuna zun leh êk an thlahdah loh nan teran vulhtute chuan an ran te an thunun tur a ni.
- (b) Sawiselna/hêkna awm apiang chu Aizawl Municipal Corporation leh anmahni huamtu Local Council-in an bawh zui ang.
- (c) Thu zâwm lova dâñ bawhchhe nawn fotute chu Mizoram Municipalities Act, 2007 hnuai Section 175 **a in ziak angin Rs 2000 chawitir an ni ang**.

15. Ui chi (breed) hlauhawm:- Department of Animal Husbandry and Dairying hnuai din Expert Committee-in ui chi sawmhnhih leh pali (24) a chhinchhiah lâk luh (import), chi thlah

(breeding) leh hralh chungchangah Aizawl Municipal Corporation chuan Ministry of Fisheries, Animal Husbandry and Dairying thuchhuah leh hriattirna chu a thlâwp tlat zel ang.

16. Ran phûmna hmun (Pet Cemetery):-

- (a) Ui leh zawhtê an thihiñ an ruang chu Mizoram Municipalities Act, 2007 section 329 zul zuia tihral a nih loh vêk pawhin, Aizawl Municipal Corporation enkawl Pet Cemetery-ah emaw, mimal enkawl ran phûmna hmunah emawtihral/phûm tur a ni.
- (b) Mi tu pawhin ran phumna hmun an buatsaih/din duh anih chuan Aizawl Municipal Corporation ah Form 3 hmang a dil tur a ni. He phalna (license) hi **kum hnîh** chhung a dam ang.
- (c) License man leh ruang phûm man hi Aizawl Municipal Corporation-inñul a tih angin azât a bituk zel ang.

17. *Ui talh, zawrh leh a sa ei khapna dân:-*

- (a) *Food Safety and Standards (FSS) Act 2006 and Regulations, 2011-in mihring ei atana chaw a tih zingah ui hi a tel ve loh avangin, ui talh leh a sa ei hi khap tlat a ni. Hei hian khawtlang hriselna tehkhâwng leh ran chunga inpekna/ngilneihna a tar lang a ni.*
- (b) *He inkaihhruaina dân zâwm lo apiang chu Bharatiya Nyaya Sanhita, 2023 hnuai Section 325 (Kum nga thleng lungin tantir anih loh pawhin pawisa chawitir/ a pahnihin) leh Prevention of Cruelty to Animal Act, 1960 hnuai Section 11-te bâkah dân leh hrai dang hman theih awm apiangte hmangin hrem theih an ni ang.*

18. *Ui chi thlah leh zawrh chungchang:-*

- (a) Ui chi thlahtir thin (breeder) zawng zawngein State Sawrkara a changtu department hnen atangin license an nei tur a ni.
- (b) Breeder leh ui zuara sumdawngte chu Aizawl Municipal Corporation (AMC)-ah an inziak lût (register) vek tur a ni.

19. Private Veterinary Hospital leh Clinic:-

- (a) Mi tu pawhin ran damdawiin leh clinic a hawng duh a nih chuan State Sawrkara a changtu department hnenah license a dîl hmasa tur a ni. Chutiang ran damdawiin leh clinic nei apiang chuan Mizoram Licensing and Regulation of Private

Veterinary Hospitals and Clinics Rules, 2022-in dān a zamte chu an zāwm tur a ni.

- (b) Ran damdawi in leh clinic hawngtu te chu Aizawl Municipal Corporation (AMC) ah an in ziak lut (Register) vek tur a ni.**

20. Ui leh zawhte tana hostel/boarding:-

- (a) Mi tu pawhin ui leh zawhte tana hostel/boarding siam a duh chuan Aizawl Municipal Corporationah Form 5hmangin license a buaipui tur a ni. License hi **kum hnih** chhung a dam ang.
- (b) Hostel/boarding neitu chuchaw tha leh tui thianghlimhnianghnar taka pēk kawngah mawhphurtu a ni ang. Tin, ranin nunphung tha leh hrisel an neih theih nan chutiang hmun neitu chuan, a tul ang zelin, damdawi hmangin a enkawl bawk tur a ni.
- (c) Ui leh zawhte enkawl that loh leh an chungahleilenna lantir kawngah tawngkain emaw ziakin emaw sawiselna emaw hēkna emaw a awm chuan Aizawl Municipal Corporation-inhma a la ang.
- (d) Dān zāwm lova bawhchhe nawn fotute chu Aizawl Municipal Corporation-in a tuk zât ang zel lei châwitir an ni ang. Tin, chutiang hostel/boarding chu khâr turin Aizawl Municipal Corporation chuan thu a nei bawk ang.

21. Inkaihhruaina dâna tar lan lohte:- He inkaihhruaina dâna ruahman zinga tel lo thil tul leh pawimawh a awm a nih chuan, Aizawl Municipal Corporation chuan hriattirna a chhuah thei ang.

22. Hriat fiah loh leh chiang lo a awmin:- He inkaihhruaina dânah hian hriat fiah loh emawchiang tâwk lo emaw a awm a nih chuan Aizawl Municipal Corporation thutlukna chu thu tâwp a ni ang.
