PROHIBITION ORDER

It is hereby notified that no person shall carry, use or store any plastic carry bags less than 50-micron thickness or any plastic articles having **single use** such as disposable plastic bottles, cups, plates, spoons and forks within AMC areas w.e.f 1st August, 2019.

Defaulters may be punishable under The Aizawl Municipal Corporation Plastic Waste Management Bye- Laws, 2019 read with The Mizoram Municipalities Act, 2007.

This prohibition shall not affect plastic carry bags specified under The Bio-Medical Waste Management Rules, 2016 & specially exempted by the AMC as per relevant Laws.
