## OFFICE ORDER

In pursuance of point No. 5 of the Minutes of the Meeting held in the Office Chamber of Secretary, UD&PA on the 21st August, 2020 in connection with Reforms under Ease of Doing Business (EODB) and Regulation 14 of the AMC Building Regulation 2012(amended in 2019), the timeline for inspection of plinth level shall be within 7 (seven) days from the date of receipt of Plinth Level Completion Certificate from Technical persons as mentioned under Section 5(17) - Annexure B-I of the AMC Building Regulation, 2012(amended in 2019).

Form of Completion of Plinth Level Certificate may be submitted as per Annexure-J of the Draft Mizoram Building Bye Law, 2020 (enclosed). Further, all ongoing Construction within the Aizawl Municipal Area will be inspected at the following stages as mentioned in point No. 6 of the Minute of the Meeting.

- a) Commencement Inspection shall be carried out within 7 days of receipt of Commencement report as ANNEXEURE-D
- b) **Plinth level** Inspection shall be carried out within 7 days of receipt of plinth level Completion certificate
- c) Completion Inspection shall be carried out within 7 days of receipt of Completion Certificate as mentioned in ANNEXEURE E

Occupancy Certificate to the Owner/applicant shall be issued accordingly subject to fulfillment of the relevant provisions of the AMC Building Regulations, 2012 (as amended in 2019) and on submission of the above reports and Certificates.
