Summary

As per census 2011 there are 51,230 households in Aizawl Municipal Corporation area having 293,416 lakh population. The Aizawl Municipal Corporation (AMC) is the first Municipal Corporation in Mizoram and the largest urban centre which is declared Smart City by the Government of India under Smart City Mission. The total area of Aizawl Municipal Corporation is 129.91 Sq.Km and has 19 wards.

The AMC runs a Solid Waste Management Centre in Tuirial located in the eastern part of the Aizawl city at 23°44'45"N latitude and 92°47'50"E longitude, approximately 20 Km from Aizawl's city center, which serves the entire municipal area since 2022, after it was handed over by SIPMIU.

Around 150 TPD of Waste is collected. All the collected wastes within the jurisdiction of AMC are transported to this centre from all corners of the city, making it a huge challenge to manage the centre, which will eventually become over burdened and AMC in its endeavor to improve the city's public amenities and to enrich the city's aesthetics, sanitation and hygiene aspects. The AMC on behalf of UD&PA department is seeking proposals from eligible Bidders to primarily undertake the work for remediation services of legacy waste via design management contract at Solid Waste Management Centre, Tuirial. The Operator is expected to install plant and machinery of required capacity for remediation of the existing legacy solid waste and subsequently reclaim the land as per MSW Rules 2016, CPCB 2019 guidelines and other applicable rules and regulations. The size of the Solid Waste Management Centre, Tuirial is approximately 31 acres.

Scope of Work: The scope of work involves preparing a comprehensive Detailed Project Report (DPR) for 'Remediation Services of Legacy Waste located at the Solid Waste Management Centre, Tuirial, Aizawl, Mizoram', for submission to the Ministry, seeking funds which are not yet sanctioned or earmarked by either central or state government. The bidder shall submit their proposals, financial and technical bid with quoted rate for remediation of legacy waste management in metric tons, on plain paper.

Conditions:

1. Aizawl Municipal Corporation will seek funding from the ministry using the proposal submitted by the successful bidder.
2. In the event that the Ministry fails to sanction funds for the project, the successful bidder:
 - i) Shall not claim any expenditure incurred for seeking approval of DPR.
 - ii) Shall not be obligated to undertake the project.
3. The successful bidder shall:
 - i) Conduct thorough research and analysis.
 - ii) Prepare a detailed project plan, including timelines, budget, and resource allocation.
 - iii) Ensure compliance with Ministry guidelines and requirements.
