- 1) Quoted rates shall be inclusive of all taxes, transportation charges, loading and unloading, etc. The quoted amount must be stated in both figures and words. Overwriting is not permitted. All corrections must be initialed and dated.
- 2) Bidder shall submit Voter ID/Aadhaar card, valid AMC Shop license and GST registration certificate along with the quotation.
- 3) Tenders shall be submitted as sealed quotations to the undersigned. The cover must be superscribed with the items being submitted, formatted as: "TENDER FOR SUPPLY OF MATERIALS - PLASTIC WATER TANK/CGI SHEET/HDPE TARPAULIN/Silpaulin". The envelope must be addressed to the Municipal Commissioner, Aizawl Municipal Corporation. Additionally, bidders must write their name and address on the envelope cover.
- 4) Tribal Tenderer shall submit a tribal certificate and Non-Tribal tenderer shall submit a Court Fee stamp worth Rs 7.50p and Income Tax Clearance Certificate.
- 5) All bidders shall submit Earnest Money Deposit (EMD) in the form of Deposit Receipt of Scheduled Bank (Term Deposit Receipt)/Deposit at call/ Demand Draft duly pledged in favour of Municipal Commissioner, Aizawl Municipal Corporation.
- 6) The Earnest Money Deposit shall release after the materials are fully delivered.
- 7) **Payment:**
- Payment should be made based on the quantity of materials delivered as per the requisitions made by the undersigned from time to time.
 - The GST registration certificate, Professional Tax Clearance Certificate, Bank Passbook (showing bank account details), and Delivery Statement signed by the concerned Recipient shall be submitted along with the bill for payment.
 - Advance payments are not permitted under any circumstances.
