### TERMS AND CONDITIONS OF DISPOSAL OF VEHICLES NOTICE NO. 01/2019

1. Interested persons/parties may submit their bid, with a PRESCRIBED FORM and PRESCRIBED COVER (ENVELOPE) for each vehicle individually in a sealed cover latest by 12:00 Noon of 28th February, 2019. The sealed cover should be dropped in the Tender Box kept at IT Section, 3rd Floor, AMC Office, Thuampui, Aizawl. The outer cover of the envelope should be super-scribed as:

- 2. Tender Form shall be signed in ink/ball point pen by tenderer or the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
- 3. Quotation should be free from correction, overwriting, using correcting fluids. If the case arises, overwriting or correction should be initialed by the bidder.
- 4. The sale of vehicle shall be strictly on "as is where is basis" and no guarantee or certificate of its worthiness or quality will be given by the AMC. The conditions of the vehicles can be inspected physically.
- 5. EMD amount is payable by means of cash wherein Receipt/Token will be issued. EMD is fixed at **Rs 2000** for each vehicle. In case the offer is withdrawn by any tenderer, the EMD deposited by him shall be forfeited.

- 6. AMC is not bound to accept the highest bid as per the Special Privatization Scheme approved by the Board of Councillor's Meeting held on 19th February, 2019. Priority shall be given to the following categories:
  - a) Having experience in the field of collection of garbage within Aizawl Municipal area.
  - b) Vehicle has been currently engaged for carrying of solid waste within his/her local council/ward area.
  - c) Priority may be given only for the bidders quoting not less than the reserve price.
- 7. The successful bidder will be required to make initial payment amounting toat least 20% of the bid amount, within a week from the selection of successful bidder. And the remaining payment will be made within 5 years at the rate of 5% simple interest per annum.
- 8. Terms and conditions not mentioned herein shall be covered by the decision of Board of Councillor's meeting held on 19th February, 2019.
- 9. EMD of unsuccessful tenderers shall be returned within 7 days of the award of the successful bidders upon submission of application for release of the same in writing addressed to The Secretary, AMC.
- 10. The successful bidder shall be required to submit documentary evidence in support of residential status (Ration Card/Voters Identity Card/Aadhaar Card/PAN Card in case of individual and registration Certificate in case of firms etc.).
- 11. The responsibility of Aizawl Municipal Corporationwith regard to watch of stationed sold vehicles ceases immediately after the successful auction i.e. after payment of initial depositto AMC. The successful bidder has to take delivery of the auctioned vehicle within a weekat his/their own expenses from the date of payment of Initial Deposit.No assistance/transportation will be provided by AMC.
- 12. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost. This office will not be responsible for any lapse on his part in this regard.

- 13. The Competent Authority of AMC reserves the right to withdraw any item or lot and to reject any/all of the quotation fully or partially or cancel the sales of vehicles at any stage without assigning any reason thereof.
- 14. Any dispute over the quality and value of the vehicle put to auction cannot be entertained after auction.
- 15. The Aizawl Municipal Corporation reserves the right to accept or reject or alter any bid without assigning any reason thereof.
- 16. In case of any dispute, with relate to auction of the vehicles the decision of the Aizawl Municipal Corporationwill be final and binding.
