Earnest money should be deposited along with the tender documents in separate envelop marked as "Earnest Money" in cash (up to Rs. 10,000) or receipt Treasury Challan/deposit at call receipt/Banker's Cheque of a recognized Bank (central or state)/fixed Deposit of a recognized Bank (central or state) /Demand Draft of a recognized Bank (central or state) issued in favour of the Commissioner, Aizawl Municipal Corporation, Aizawl, Mizoram. A part of earnest money is acceptable in the form of Bank Guarantee also.

Sealed Earnest Money shall be enclosed inside sealed tender document shall be submitted together in another sealed envelope superscripted with names of work and due date of opening. The envelope marked tender shall be opened whose Earnest Money, placed in the other envelope mark as Earnest Money is found in order.

## Additional condition for CPWD - 6

The tenderer shall abide by the rule and regulation under relevant state sale tax Acts/Value Added Tax (VAT) Act/Labour cess, GST etc. as amended from time to time and deduction for sale Tax/VAT/Labour Cess, GST on work contracts shall be made from the gross value of the work done from all bills as per provision of above stated Acts. Nothing extra on account of this deduction shall be paid. In case this amount is not payable to the State Government/Aizawl Municipal Corporation at a later date due to subsequent decision of the Court or Government the amount already deducted or the balance yet to be deducted if any from the remaining work yet to be paid/done, the amount shall not be refunded/paid to the contractor and contractor will have no claim for the same. The contractor may therefore, quote his rate accordingly.
